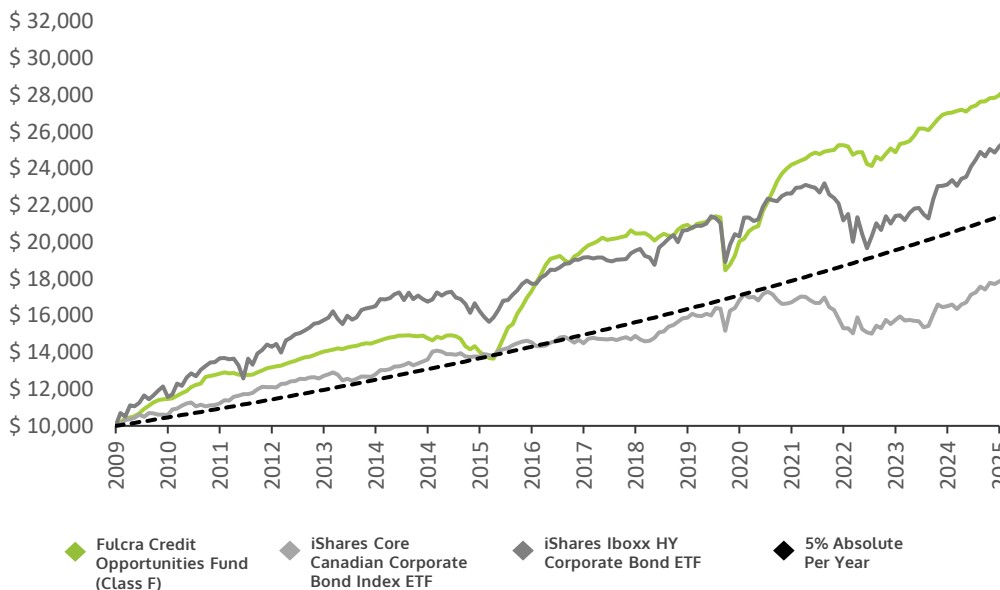

INVESTMENT OBJECTIVE & STRATEGY

The Fulcra Credit Opportunities Fund (the "Fund") seeks to generate consistent total returns with a primary focus on capital preservation through investing in bonds, loans and other fixed income securities but may also hold equity and other equity-like securities. We employ a fundamental due diligence and value investing approach to identify undervalued securities. The Fund hedges foreign currency exposure and does not use leverage.

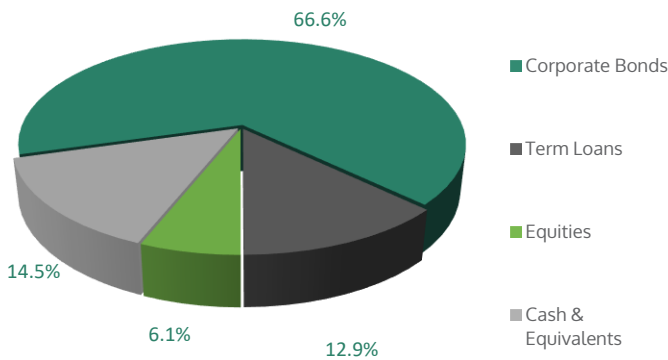
Note 2: Returns are shown for Class F units of the Fund for the periods ended at the date indicated at the top of this document. Returns assume the reinvestment of all distributions and include management fees and operating expenses, but do not include any taxes payable by an investor. All returns greater than one year are compounded annual returns. Returns since inception are annualized returns since July 1, 2009.

Note 3: Performance fees are equal to 15% of the Fund's annual return exceeding 5% (or "hurdle rate"). Performance fees are only payable when the Fund's net asset value is above the value when performance fees were last paid (or "high water mark"). The Fund is also responsible for paying its own operating expenses, including but not limited to legal and audit fees, fund administration fees, custodial charges, costs of providing information to unitholders, brokerage fees, interest, and taxes.

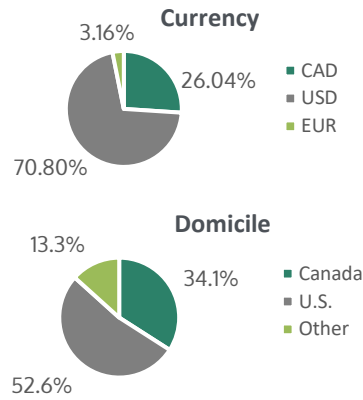
Note 4: The annual yield an investor would receive if the most recent fund distribution stayed the same going forward. The yield represents a single distribution from the fund and does not represent the total return of the fund. The yield is calculated by annualizing the most recent distribution and dividing by the fund's NAV from the distribution date. This figure is net of management fees and other fund expenses.

Note 5: The yield an investor would have received if they had held the fund over the last twelve months, assuming the most recent NAV. The 12-month trailing yield is calculated by summing any income distributions over the past twelve months and dividing by the fund's NAV from the as-of date. This figure is net of management fees and other fund expenses.

GEOGRAPHIC ALLOCATION

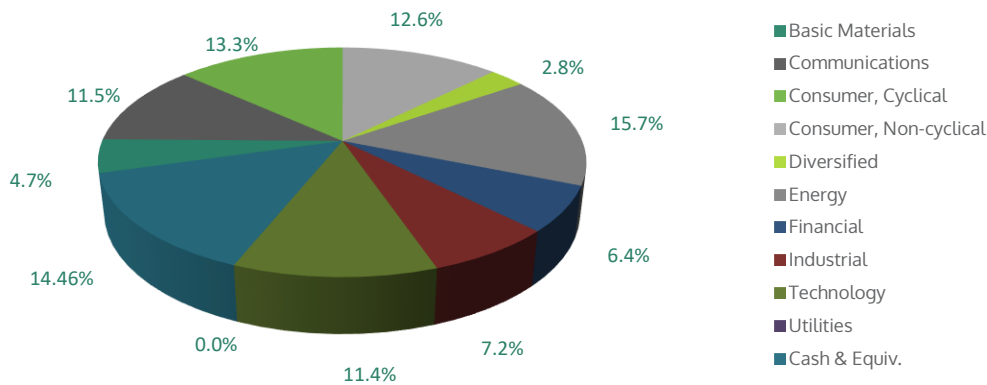
